To ensure that the public has sufficient opportunity to scrutinise these documents and make their comments the consultation period for these two documents will run for six weeks between:

Thursday 22 March and Thursday 3 May, 2018

You are invited to make comments on these documents directly online or by completing a comments form. However you choose to make your comments please ensure that they reach the Council by **5pm Thursday 3 May 2018**. It is important to note that this extended consultation period applies **ONLY** to the two documents referred to above. Comments in relation to Local Plan and other supporting documents must be received by 4 April 2018, late submissions will not be accepted.

A further supporting document, the Habitats Regulations Assessment - Appropriate Assessment, will be published on the Council's website in the week commencing 2nd April 2018. Its publication will be clearly indicated on the Council's website and you will be able to make comments on this document for six weeks following its publication.

Only those representations made within the consultation period will be taken into account by the Inspector as part of the examination.

Please note that copies of all representations received will be made available for the public to view and cannot be treated as confidential. Personal data will however be processed and held in accordance with the Data Protection Act 1998.
